The Buyer agrees to the following terms of the Puppy Transport and Delivery Agreement:

\_\_\_\_\_ The Buyer is required to select a Delivery Date and pay for Flight Costs no less than **thirty (30)** days before the Delivery Date *unless* the Buyer is purchasing a Dog that is 6+ weeks of age at the time the Sales Contract is signed. The Buyer will work with the Seller to select a date that is agreeable to both parties, and the Buyer will reimburse the Seller for Flight Costs within **twenty-four (24) hours** of receiving ticket confirmation from the Seller. Failure to reimburse the Seller in that timeframe will result in ticket cancellation and a reselection of Delivery Date.

\_\_\_\_\_ The Buyer will meet the Seller at the Arrival Airport within the above stated Pickup Timeframe. Failure to meet within the Pickup Timeframe may incur additional fees (at Buyer's sole expense) to change the Seller's return flight, provide hotel accommodations if a same-day flight is no longer available, OR purchase a return trip if the Buyer cannot meet on Date of Travel without providing the Seller with advanced notice. "**Advanced notice**" is **no later than 60 minutes before departure from Seller's home airport**. The Seller can be reached at (512) 788 – 4714 or (512) 481 – 8396 in case of emergency.

\_\_\_\_\_ The Buyer understands that **ONLY** the listed Buyer may take possession of the Dog at the Arrival Airport. The Seller will **NOT** release the Dog to an agent of the Buyer. The Buyer must present valid identification that matches the information provided on the Sales Contract prior to the Dog being released from the Seller's possession.

\_\_\_\_\_ The Seller will meet the Buyer at the above listed Arrival Airport. The Buyer understands that the Seller is unable to leave the Arrival Airport for delivery and the Buyer shall not ask the Seller to make arrangements to meet elsewhere. It is the Buyer's responsibility to ensure they are able to meet the Seller at the Arrival Airport.

\_\_\_\_\_ The Buyer must pay the total Purchase Price (\$ \_\_\_\_\_) of the Dog and the Total Travel Costs (\$ \_\_\_\_\_) no less than **three (3) days** before the Date of Travel. Failure to pay the total amounts due by \_\_\_\_/\_\_\_\_/20\_\_\_\_ will result in travel cancellation. Failure to pay all amounts due within ten (10) calendar days of Delivery Date listed in Sales Contract (\_\_\_\_/\_\_\_\_/20\_\_\_\_) will render the Sales Contract void. **All funds paid to the Seller will then be non-refundable.**

\_\_\_\_\_ The Seller will make every reasonable effort to arrive during the Pickup Timeframe at the Arrival Airport. The Buyer **shall not** hold the Seller liable for delays or cancellations of travel due to the fault of the selected Airline. The Seller will keep the Buyer informed of any and all changes to the Arrival Time or Pickup Timeframe. If the Buyer is unable to take possession of the Dog due to the

changes in travel itinerary owing to the fault of the Airline, the Seller will work with the Airline to credit future travel for a second delivery attempt.

\_\_\_\_\_ The Seller will make every reasonable effort to arrive on the Date of Travel following the pre-arranged travel itinerary. If travel delays or cancellations occur owing to the fault of the Seller, the Seller will reschedule travel itinerary with the Buyer and be responsible for all fees or costs associated with the changes in travel plans.

\_\_\_\_\_ The Seller will make every reasonable effort to keep the Dog safe during travel. The Buyer further understands that potential risks associated with air travel do exist, especially with brachycephalic dogs like Boxers. Buyer agrees that they shall hold harmless and indemnify Seller against any losses, liabilities, and claims arising out of or relating to injury or death of the Dog due to reasons associated with air travel or negligent actions of the Airline.
